### Report of the Online Meeting Held on 29/09/22

An online meeting of the Anti-Ragging Committee, all other faculty members and the newly admitted students of Semester I, 2022 was held over Google Meet on 29/09/22 at 12.30 pm to explain the Anti-Ragging guidelines as provided by the UGC to the students and the process of filling up the Anti-Ragging Affidavit as available in the Anti-Ragging website. The meeting was chaired by Dr Pradipta Kumar Basu, Officer-in-Charge, GGDC, Mangalkote. The discussions at the meeting were followed by the resolutions as mentioned below and were unanimously agreed to by all the stakeholders:

- 1. The Anti-Ragging Committee (ARC), each year, at the beginning of new session will hold awareness camps with both new and senior students.
- 2. The ARC will draw up a guideline for the students to help them fill up the anti-ragging affidavits as required by the UGC norms.
- 3. As soon as possible an Anti-Ragging Squad (ARS) will be formed headed by the HOI and including student representatives. The primary purpose of the ARS would be to keep vigilance and report incidents of harassment and ragging to the ARC.
- 4. Henceforth it would be mandatory for the students to fill up the anti-ragging affidavit, signed by themselves and their guardians at the beginning of each new session.
- 5. The anti-ragging helpline number and the anti-ragging guidelines would be put up in the college premises and would also feature in the college brochure/prospectus.
- 6. Workshops will be organized, where the HOI will discuss the anti-ragging provisions to the students before the commencement of each session.

The meeting ended with a vote of thanks to the chair.

REPORT OF THE SENSITIZATION PROGRAMME HELD ON 23/11/22

The following points were discussed in the said programme:

- 1. The ARC will draw up a guideline (in form of a ppt) which will help the students in explaining the steps to fill up the online anti-ragging affidavit, as many of them were quite apprehensive of signing any online declaration.
