NOTIFICATION

In partial modification of the earlier notification vide no. R-S/N-1/228, dated 22.04.2024, regarding the Guidelines for Execution of Vocational Education and Training for UG Students in the Academic Session 2023-27, it is notified for information of all concerned that the following points of the said notice shall be read as hereunder instead of earlier:

- 2 (i) Colleges shall collect ₹350/- (Three Hundred Fifty only) instead of Rs.500/- (Five hundred Only) per student per semester (third, fifth and sixth semester) for Minor course under Vocational Education and Training for the Academic session 2023-27 and the respective colleges will collect such fee as above during the phase of filling up of examination forms for the preceding semester.
- 2 (j) College shall retain ₹7/- (Seven only) per student per semester from the semester fee for Minor Courses.
- 2 (k) Respective college shall deposit ₹343/- (Three Hundred Forty Three only) collected for Minor Courses per student per semester to the University's Account from the fee collected for Minor Courses
- 2 (l) Respective college shall send a Minor-course wise list (soft copy) of students to the University as well as WEBEL within 10 days from the last date of collection of examination fee for the preceding semester.
- 2 (m) Respective college shall disburse the university's share of total fee for Minor Courses in the University's Account within 5 days from the date of submission of the list of students of the respective semester to the University.
